## **Commercial Customers** **\$1,500 rebate per Level 2 dual head charger**

(Maximum of 50% of the installed cost, rebate not to exceed \$1,500.)

Menasha Utilities offers an incentive to encourage charging for electric vehicles (EV).

### **Eligibility**

- Purchase and install an *Energy Star* Level 2 EV Charger.
- Menasha Utilities electric customer whose account is in good standing.
- Have your EV DOT registration registered and EV charger installed at your primary residence or business that is receiving electricity from Menasha Utilities.
- EV charger installed on an electric meter billed under a Menasha Utility electric service rate.
- Own or Lease a registered EV that can receive a Level 2 charge.
